

## **SCHOLARSHIP APPLICATION**

**Gerard L. Pellegrini** was a renowned trial lawyer who established a reputation for excellence in representing working people in Western Massachusetts and throughout the Commonwealth of Massachusetts. In 1957, he founded the law firm of Pellegrini, Seeley, Ryan & Blakesley, P.C. He died in 2015, after having practiced for 50 years. Sixty years after its founding, the firm continues his legacy of advocating for injured people in courts and administrative agencies throughout Massachusetts.

As a way of commemorating the 60th anniversary of the law firm, its attorneys and staff created the **Gerard L. Pellegrini Scholarship**. The scholarship program recognizes Mr. Pellegrini's commitment to working people by awarding grants to members of locals affiliated with the Western Mass Area Labor Federation (formerly the Pioneer Valley Central Labor Council), or members' spouses or legal dependents. A total of \$5,000.00 in grants will be made. Grants are available to students for college education and for trade apprenticeships.

In further recognition of the importance of organized labor in our society and economy, applicants will be reviewed, in part, based upon creation of an essay to answer the question "what challenges are faced by the labor movement in 2020?" The criteria for selection of grant recipients will include: a.) quality of essay creation, b.) participation in extracurricular activities (including work) and c.) grades/grade point average.
